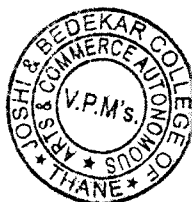

Item 07.04: Dr. Tokekar informed and approved the details of the verticals:

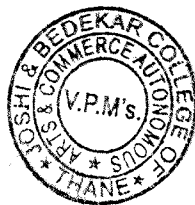
1. Field Projects (FP) pertaining to profile of Thane City and socio-economic, political and cultural aspects of Velneshwar Village
