Item: 6.03: MLISC curriculum and examination pattern of all semesters (4) was discussed and approved in previous meeting. Following changes in Sem 3 and 4 were discussed and approved.

In semester 3 and 4 under Major elective option of any one MOOC of library science or allied subject from SWAYAM, Coursera, et. is included.

Considering schedule of SWAYAM courses it was pointed out by Ms. Sampada Jadhav that they face the problem in semester I. But there will not be any problem for 2nd and 3rd semesters. It was decided that students can complete these courses in advance.
