Item 3.02: The Minutes and Action Taken Report (ATR) of the previous Meeting held on 26th February 2022 were read and confirmed

Item 3.03: Mode of awarding degree at two levels and later entry in third semester was discussed

Prof. N.S Barse explained the need of awarding degree at two levels and later entry in third semester and proposed following mode of awarding degree at two levels and later entry in third semester

The degree of Master of Library & Information Science (MLIS) course shall be awarded to a candidate who has completed a regular course of study for not less than two years and qualified the examinations after Semester-1, Semester-2, Semester-3 and Semester-4 in the manner as prescribed by the appropriate authority of the Institution from time to time. At the end of one

year, after successful completion of 2 semesters, any candidate may take the exit option. After successful completion of 2 semesters, all candidates will be awarded the degree in the nomenclature of Bachelor of Library & Information Science / BLISc.

Provision of Lateral Entry into Third Semester: A candidate who has qualified the following examination shall be eligible to seek admission in the third Semester of the course under Lateral Entry Scheme: (i) Who has passed first and second Semester of Master of Library and Information Science (M.L.I.Sc.) Integrated Course of this University or any other University recognized as equivalent thereto. (ii) Who has passed Bachelor of Library and Information Science (B.L.I.Sc.) programme of this University or any other University recognized as equivalent thereto

Dr. Satish Kanmadi appreciated the change made under the NEP 2020 guidelines. He suggested there should be control on perusing BLISc and MLISc simultaneously from the students.

Mrs. Sampada Jadhav asked about eligibility for Lateral entry. It was made clear that a candidate (i) Who has passed first and second Semester of Master of Library and Information Science (M.L.I.Sc.) Integrated Course of this University or any other University recognized as equivalent thereto. (ii) Who has passed Bachelor of Library and Information Science (B.L.I.Sc.) programme of this University or any other University recognized as equivalent thereto will get admission in the second Year of MLISc

Mrs. Kadambari suggested that there should be entrance exam for BLISc students from Open Universities in the second year. It was made clear that Two Week Bridge Course will be conducted for them.

The changes in exit (BLISc after two semesters) and entry (Lateral Entry in Second Year) to the course were approved by all the BoS members and forwarded to Academic Council for approval.
